With our presentations from both the Water Finance Exchange (WFX) and International Consulting Engineers during our March 1, 2023 meeting the board was given a presentation that outlined the philanthropic funding opportunities from WFX and the engineering network of ICE that will be the key to reaching our current needs and planning for our future ambitions.

The attached plan provides a draft of the Corporation's needs for short and long-term solutions to address water infrastructure and facilities.

Analysis:

ICE has met with management staff to review some of the vision and this presentation before the board will allow you to provide input into this process. WFX will work on securing finances to pay for these projects.

Staff Recommendation:

Receive presentation and provide input to staff and ICE on the Master Plan work for the Corporation.

Board Action:

No formal action is required.

Summary:

Both companies are nationally recognized for their expertise in the areas of finance, water/environmental policy and engineering. Background:

On November 29, 2022, the board approved entering into an agreement with Texas Rural Water Association for the use of their GIS/Mapping services. These services include mapping all water lines throughout the NWSC system which will provide our staff the ability to access customer locations, accounts with details including pictures and data to assist both field and office staff with up-to-date information to respond to repairs, emergencies or customer concerns about their accounts.

Analysis:

The estimate quoted to the corporation for GIS/Mapping on the November 19th meeting was \$10,000. The amount was approved with a unanimous vote. Once the TRWA staff arrived on-site in May 2023 it was determined the final price would increase from the original amount. This agreement must be ratified in order to authorize payment for the full amount of services provided.

Staff Recommendation:

Authorize staff to ratify the original agreement for the projected amount.


Board Action:

I. Summary

The Texas Rural Water Association (TRWA) is pleased to submit the following proposal to South Texas Water Authority for the GPS data collection and attribution of Nueces WSC water system infrastructure features.

As a state-wide water and wastewater utility trade association TRWA provides geospatial technology designed specifically to meet the needs of small and rural communities. TRWA utilizes cutting-edge technology to provide practical infrastructure management datasets.

TRWA proposes to collect locations for each system feature identified in the project scope using sub-meter Global Navigation Satellite System (GNSS). In addition, attribute information will be gathered while in the field for each feature collected. The entire data set will undergo various quality control measures to ensure data integrity before final delivery.

Based upon the enclosed services to be provided, TRWA's proposed price is for both GPS and attribute collection, and GIS data processing. These calculations are based upon the estimated number of features provided by Nueces WSC.

II. Objectives

TRWA understands the objective of this project is to provide the <u>Nueces</u> <u>WSC</u> with a geo-database containing both positional and physical attribute information for the system features within the service area.

III. Procedures/Scope of Work

To achieve the objectives listed above, the following scope of work will be performed.

 Collect coordinate information for each above ground feature in the system. Sub-meter accuracy will be the goal of all locations. All features will be collected with the antenna at the center of the feature unless an offset is performed in which case measurements will be taken from the center of the feature.

The estimated number of features to be collected during this project is listed below:

• System Distribution Assets: 1,050 (estimates)

- 1,050 – water meters

Collect physical location and attribute information for each above ground feature in the system (water meters). Attribute information (water lines) shall be gathered by field personnel directly from asbuilt maps when obtainable; otherwise, the information will be provided by the <u>Nueces WSC</u>.

*Nueces WSC will perform a diligent effort to prepare the requested features in advance including clearing brush, grass, and dirt to more efficient collection.

Equipment Specifications

TRWA will use the following equipment set up during the data collection process.

1. EOS Arrow 100 receiver. – The Arrow 100 to acquire sub-meter accuracy. This unit is paired with a tablet or handheld device.

Software Specifications

TRWA will use a combination of the following software setups during data collection and post-processing tasks.

- <u>ESRI Collector</u> Software developed for field collection and paired with ESRI ArcMap Desktop software.
- **<u>Diamond Maps</u>** Web based software to aid in digitizing maps provided and for data collection in the field.
- **ESRI ArcGIS (ArcMap) Suite 10.3 (or higher)** will be used in conjunction, to configure, produce, and publish digital and hardcopy maps.

Quality Control Procedures

TRWA understands the commitment to quality that our customers expect. To ensure a common goal of providing excellent customer service and continuous improvement in the development, production and delivery of our products and services, we have incorporated the following quality control measures.

To ensure quality control during the data collection process, the TRWA technician will perform mission planning to determine the best times to collect data depending upon the satellite configurations. The GPS equipment will also be configured to meet the recommended settings for capturing sub-foot positional data.

Completion of additional data collection will be determined based upon the as-built drawings supplied by the <u>Nueces WSC</u>. Each feature on the as-builds will be marked as it is collected. If any new features are found while in the field, the feature will be collected and will be noted as a new feature in the comments section for the feature class.

Data Backup Procedures

To prevent the loss of data during the project, the raw GPS data will be downloaded daily to a local desktop machine or laptop computer. In addition, this data will be copied to a secure server located at the TRWA office. Each week when data is differentially corrected, the base station files along with the updated personal geodatabase will be saved on a local desktop machine then backed-up on the server.

Assumptions

The following assumptions have been made based upon currently available information:

- 1. Physical attribute information will be gathered in the field for features that are accessible; however, if determinations cannot be made from as-built drawings, this information will be obtained from **Nueces WSC**.
- 2 <u>Nueces WSC</u> will supply an employee to accompany our field staff to locate and collect the desired features.
- 3. Infrastructure locations are marked and/or accurately located on as-built drawings, and/or will <u>be marked or viewable in the field as well</u>, for TRWA data acquisition with the GPS data logger.

IV. Project Schedule

The anticipated start date for this project is reliant on weather permitting and barring any unforeseen circumstances that may arise to delay the project timetable. The anticipated completion time for just the GPS field work is **5** workday(s). (This depends on no unforeseen circumstances or bad weather.)

V. Deliverables

The following deliverables will be presented to the <u>Nueces WSC</u> at the completion of the project. The deliverables will include the following:

- A geo-database compatible with any GIS software. The database will contain all attributed features collected and digitized as listed in the scope of work.
- Wall Map (42" x 42")
- One-year subscription to Diamond Maps
- Published digital map for viewing using Diamond Maps available for "in the field" mobile viewing or any computer or device.
- Standard GIS datasets (streets, roads, streams, etc.) Aerial imagery or topography maps are available but <u>may</u> be an additional expense.

Estimated Cost of GPS/GIS Mapping Project:

*** Expenses incurred by the TRWA Tech include the reimbursement of all mileage costs. These are miles to and from the **Nueces WSC** from the TRWA's staff or subcontractor's office, miles incurred within the system, and to and from the hotel accommodation, if applicable. This is based on an approximate **5 workday(s) in the field** for GPS Data Logging, over approximately 1 work week(s) (weather permitting and barring any unforeseen circumstances). Other expenses are for daily per diem & incidental charges.

Collect, attribute and process GPS data for \$9.00 **per feature:** *Note: This cost for service is only given to TRWA members and is less than the competitor's standard rates. In addition, standard costs for this service are \$10 but a discount is being given due to location and system size.

Total Features: 1,050 @ \$9.00 per = \$9,450.00

(Note: This amount can vary higher or lower, depending on the actual number of features located. The cost above is for field data collection only.

<u>Estimated</u> TRWA Tech Mileage of 554 miles. Collection done in one trip/stay; presentation done on a second trip - \$0.655 per mile: (Based on total miles incurred to complete project. This could be depending on actual miles)	\$362.87
<u>Estimated</u> Daily Per Diem (Rate of \$150) x 5 Wakdays: (This could possibly be higher or lower, depending on actual days needed to complete the project.)	\$750.00
<u>Estimated</u> processing time to digitize map data and complete deliverables. (24 hrs. @ \$65 per hour)	\$1,560.00

Total project will provide all as-built data to be transferred to a digital map including lines, meters (data transfer from billing software), and all additional points collected in the field. This provides a year subscription to Diamond Maps. If ESRI ArcMap is preferred, an additional \$1600.00 would be added for subscription cost. This includes staff training and presentation of completed map project, as well as map support from our GIS technician if TRWA membership is maintained.

Upon completion, the Texas Rural Water Association will invoice <u>South Texas</u>. <u>Water</u> for the services provided. TRWA will maintain records of actual time and expenses incurred regarding mileage and processing hours. <u>South</u> <u>Texas Water Authority</u> would only be billed for actual time and expenses incurred if they are less than the per diem rates.
